

This privacy policy governs the use of offer Heartbout LLC . (hereinafter-the "Service") information received from users of the social network HeartBout ("Users").

Use of the heartbout app This privacy policy governs the use of offer Heartbout LLC. (hereinafter-the "Service") information received from users of the social network Heartbout ("Users").

1. Information received by the Service

1.1. The service collects, accesses and uses for certain purposes the technical and other information related to the User.

1.2. Technical information is not personal data.

1.3. Technical information also means information that is automatically transmitted to the Service during the use of the heartbout app.

1.4. When registering on the heartbout app and subsequent use of the heartbout app, the User provides the Service with an e-mail address and login. The information provided is not personal data.

1.5. The service processes technical and other information related to the User during the entire period of use of the heartbout app by the User.

1.6. The user gives his consent to the Service to transfer information to third parties in pursuance of agreements between the Service and the User, even when such transfer is carried out on the territory of other States (cross-border transfer).

2. Purposes of use of information provided by the User

2.1. The information provided by the User is used by the Service solely for the purposes of: providing technical support to the User; consideration of the user's appeals and claims; registration and user identification on the heartbout app ; directions to the e-mail address of the User of information and advertising messages; improvement of work and modernization of the heartbout app.

3. Measures taken to protect the information provided by the User and guarantee the Service

3.1. The service takes necessary and sufficient legal, organizational and technical measures to protect the information provided by the Users from illegal or accidental access, destruction, modification, blocking, copying, distribution, as well as other illegal actions of third parties with it, by limiting access to such information by other users of the Service heartbout app, employees and service partners, third parties (except for providing the Service with information necessary for the performance of obligations to the User), as well as imposing sanctions on such persons for violation of confidentiality with respect to such data.

3.2. The service guarantees that the information provided by Users is not combined with statistical data, is not provided to third parties and is not disclosed, except as provided in the Policy.

3.3. The service does not sell or transmit User information separately. Such information may be transferred only in case of partial or full reorganization of the Service.

3.4. The service takes technical and organizational measures to provide the User with the opportunity to access the information provided to them, to edit such information, to determine the settings of third parties access to such information.

4. Rights Of The Service

4.1. The service has the right to conduct statistical and other research on the basis of impersonal information provided by the User. The service has the right to provide access to such studies to third parties for advertising targeting. The user agrees to such research and to receive targeted advertising through the adoption of the Policy. The user can refuse such consent at any time by contacting the Service at the address specified on the relevant page of the Service heartbout app. The user can also independently, if there is a technical possibility on the User's device or in the software on the User's device, prohibit the device or software from transmitting information through the Service heartbout app necessary for advertising targeting.

4.2. The service has the right to provide information about Users to law enforcement agencies or other state bodies within the framework of judicial process or within the framework of investigation on the basis of a court decision, a forcibly executed request or in the course of cooperation.

4.3. The service has the right to provide information about Users to third parties to identify and prevent fraud, to resolve technical problems or security problems.

5. New edition

5.1. The service reserves the right to make changes to the Policy. The User is obliged to read the text of the Policy every time he / she accesses the Service heartbout app.

5.2. The new version of the Policy shall enter into force upon its posting on the Serviceheartbout app. Continued use of the Service heartbout app after the publication of the new version of the Policy means acceptance of the Policy and its terms by the User.

5.3. The user must not use the Service heartbout app if the User does not agree to the terms of the Policy.
